Currently, there are no state-level breed-specific laws, but multiple states regulate the class of wolf-dog hybrids, as do a number of local jurisdictions. Our estimate shows there are jurisdictions in at least **40 states with breed-specific laws.** 

#### Notes:

- [1] Not all jurisdictions within a county that restricts specific breeds are subject to the county law. This document lists all incorporated cities within such counties and in several states, also includes incorporated towns and villages, but makes no determination as to whether these incorporated municipalities are required to abide by county law.
- [2] Sources are derived from the DogsBite.org website and Wikipedia. This document makes no determination as to whether the military facilities listed actually contain privatized housing.
- [3] Jurisdictions in 54 countries around the world have breed-specific laws. **43 of those countries have national level breed-specific laws,** such as England, Spain, France, New Zealand and dozens more.
