## ADOPTION AGREEMENT

This Adoption Agreement is made and entered into as of the latest date of signature below by and between Spokane County Regional Animal Protection Service (SCRAPS) and the above-mentioned individual, hereinafter referred to as "ADOPTER".

Whereas, ADOPTER wishes to adopt the animal(s) described herein, ADOPTER acknowledges and agrees to the following:

1. ADOPTER and their respective heirs and assigns accept full responsibility for the care of the animal (including any and all necessary veterinary care) from the date ADOPTER takes physical possession and custody of the animal. Only once SCRAPS transfers physical possession and custody of the animal to ADOPTER shall this Adoption Agreement be fully executed and legal ownership be passed from SCRAPS to ADOPTER.
2. SCRAPS, its agents, and its representatives, make no representations or warranties, either express or implied, concerning the animal's previous ownership or guardianship, pedigree, suitability for ADOPTER's home, or current or future health, behavior, temperament, mental disposition. ADOPTER understands that they have no right to reimbursement for any expenses incurred in conjunction with or as a result of this Agreement's execution.
3. ADOPTER represents that they have never been subject to legal action for cruelty or neglect of an animal and that they have never owned an animal who has been confiscated by any animal protection or humane organization for violations of state or local animal welfare laws or an animal adoption agreement.
4. ADOPTER and their respective heirs and assigns agree to indemnify and hold harmless SCRAPS, its agents and representatives, against any and all manner of actions and causes of actions, suits, debts, dues, accounts, bonds, covenants, agreements, judgments, claims, and demands whatsoever arising out of or relating to the adoption, behavior, health, possession, and/or placement of the animal.
5. ADOPTER has read and understands this Adoption Agreement, has had the opportunity to ask questions of the representatives of SCRAPS, and voluntarily signs this Adoption Agreement.
